We use and collect Personal Data about you to provide you with our services. When we do so we are subject to the UK General Data Protection Regulation (UK GDPR) which applies across the United Kingdom and EU GDPR which applies across the United Kingdom and European Union. We are responsible as 'controller' of that personal information for the purposes of those laws.

# Our collection and use of your personal information

## Whether information has to be provided by you, and if so why

We require you to provide us with the personal data to enable us to provide our emergency assistance Central Heating Products and Emergency Central Heating repair services to you. We will inform you at the point of collecting information from you, whether you are required to provide the information to us.

However, if you do not provide us with it, we will not provide services.

#### The impact of our use of your personal information

## Transfer of your information out of the UK and EEA

We may transfer your personal information outside of the UK and EEA to countries which do not have the same data protection laws as the UK and EEA (such as the USA).
